

2024 Annual Membership Meeting Minutes

May 14, 2024

- 1. Meeting was called to Order at 6:01 PM
- 2. Determination of Quorum Dale mentioned that the meeting did not at this point meet quorum. More people joined as the meeting went on, and Quorum was finally obtained.
- 3. Dale made introductions to the owners.
 - Dale introduced himself as the Manager for Fairways of Heath Crossing.
 - Dale also introduced the Current Board Members

 - Rachel Davis
 - Dan Volpini

- 5. Dale then discussed the need and process for Annual Meetings.
 - Required every year by the Governing Documents.
 - Quorum for the meeting is 50%, which is 52 homeowners.
 - At the meeting the Association will:
 - Review Financials
 - Review work that is being done in the community.
 - Discuss any issue that is facing the HOA.
 - Election of Officers.
- 6. Dale then went over work being done in the community:
 - The Board is working on landscaping issues in certain areas.
 - The Board is also working on clearing some of the dead trees along the path.
 - Signs to limit liability on the trails are in the process of going up.
- 7. Dale then went through the Financial Review
 - As of 12-31-23
 - Operations: \$119,311.64
 - Reserves: \$50,605.88
 - CD: \$100,000.00
 - As of May 15, 2024
 - Operations: \$53,897.79
 - Reserves: \$52,778.39
 - CD: \$105,250.00
- 8. Dale then discussed the Board's Accomplishments for the last year.
 - Consolidated the HOA into one organization, removing it from the Developer.
 - Got a working Budget for 2024.

- Opened a CD to get a higher interest rate of return on money the HOA wasn't currently using.
- Put signs up to limit liability on the trails.
- 9. Dale then discussed the Board Goals for the Coming year:
 - Continue to keep the Community financially sound.
 - More community Events, this will require more volunteers to help set up.
 - Get landscaping where the community wants it.
 - Clean out old dead trees from the trail.
- 10. Dale then introduced the two candidates for the Board.
 - Andrea Woodworth Was not able to attend the meeting.
 - Emmanuel Arias Talked about his qualifications, and his vision for the community.
- 11. Dale then discussed the process for Voting for the Board of Directors.

 - Voting is open now, and will close at 6 am tomorrow.
 - The results will be anounced in the morning.
